Introduction

Thank you for choosing **A N Express Limited** ("we," "us," "our"). Protecting your privacy and maintaining the confidentiality of your personal information is of utmost importance to us. This Privacy Policy explains how we collect, use, disclose, and protect your personal information when you use our money transfer services, the **A N Express** website (https://www.anexpress.com/), or the **A N Express** Mobile Applications (collectively referred to as the "Service").

By using our Service, you acknowledge that you have read, understood, and agree to the collection, use, and disclosure of your personal information in accordance with this Privacy Policy. Terms used in this Privacy Policy, unless otherwise defined, carry the same meanings as in our **Terms and Conditions**.

Information We Collect

We may collect the following types of personal information from you:

Information You Provide Directly

- **Personal Identification Information:** Name, address, phone number, email address, date of birth, and government-issued identification (e.g., passport, driver's license).
- **Transaction Information:** Details about the money transfers you perform, including the amount, currency, recipient details, and transaction history.
- Payment Information: Bank account details, credit/debit card information, or other payment method details.

Information Collected Automatically

When you interact with our Service, we may collect information automatically, including:

- **Device Information:** IP address, browser type, operating system, and device identifiers.
- **Usage Data:** Pages visited, time spent on the Service, and other diagnostic data to understand how you interact with our Service.
- Location Data: If you permit, we may collect location information to enhance the Service.

Information from Third Parties

We may receive personal information about you from third-party sources, such as:

- Financial institutions and payment processors.
- Fraud prevention agencies or compliance databases.

How We Use Your Information

We collect and use your personal information to:

1. Provide the Service

- Process transactions and deliver money transfer services.
- Verify your identity to comply with legal and regulatory requirements.

2. Improve the Service

- Understand user behavior to optimize functionality and user experience.
- Diagnose technical issues and ensure service reliability.

3. Ensure Security

- Monitor for fraudulent, unauthorized, or illegal activities.
- Protect your account and our systems from misuse.

4. Communicate with You

- Send transaction confirmations, service updates, or customer support communications.
- Share promotional offers (only with your explicit consent).

Sharing Your Information

We may share your personal information under the following circumstances:

With Service Providers

 Third-party vendors who assist in delivering the Service, such as payment processors, customer support providers, and IT infrastructure providers.

For Legal and Regulatory Purposes

- To comply with legal obligations, such as anti-money laundering (AML) or counter-terrorism financing (CTF) regulations.
- To respond to lawful requests from government authorities or law enforcement agencies.

With Your Consent

• When you explicitly consent to sharing your information with specific parties.

Protecting Your Information

We take reasonable measures to protect the confidentiality and security of your personal information. However, please be aware that no security measures are perfect, and we cannot guarantee the security of your information.

Your Privacy Rights

You have rights regarding your personal information, which include:

- 1. Access and Correction: Request access to or correction of the personal information we hold about you.
- 2. **Data Portability:** Obtain a copy of your personal information in a structured, commonly used format.
- 3. **Withdraw Consent:** Withdraw your consent for certain data processing activities (e.g., marketing).
- 4. **Delete Data:** Request the deletion of your personal information, subject to legal and regulatory obligations.

Retention of Information

We retain your personal information for as long as necessary to fulfill the purposes outlined in this Privacy Policy or to comply with legal, regulatory, and compliance requirements.

International Transfers

Your personal information may be transferred to and processed in countries outside of your country of residence, including countries that may have different data protection laws. We will take appropriate measures to ensure that your personal information receives an adequate level of protection as required by applicable laws.

Children's Privacy

Our services are not intended for individuals under the age of 18. We do not knowingly collect personal information from children. If we become aware that we

have collected personal information from a child without parental consent, we will take steps to delete such information as soon as possible.

Tracking & Cookies Data

We track activities on our Service and store certain information using cookies and other tracking technologies.

Cookies are little data files that could contain an anonymous unique identification. Cookies are little text files that a website sends to your browser and stores there. Beacons, tags, and scripts are just a few of the tracking technologies that are used to gather data, track users, and analyse and enhance our service.

You can tell your browser to always reject cookies or to let you know when one is being sent. However, you might not be able to utilise all of our Service if you refuse to accept cookies. Examples of Cookies we use:

- Session Cookies that are used for Session Cookies to operate our Service.
- Preference Cookies that are used for Preference Cookies to remember your preferences and various settings.

We will take all reasonable measures to protect your data and treat it securely in line with this Privacy Policy, and no transfer of your Personal Data to a company or individual will ever occur.

Data Security

We care about the security of your data, but keep in mind that no form of electronic data storage or transfer via the Internet is completely safe. While we make an effort to protect your Personal Data with commercially reasonable measures, we cannot provide perfect assurance of security.

Service Providers

These third parties have access to your Personal Data only to perform these tasks on our behalf and are obligated not to disclose or use it for any other purpose.

Analytics
